# VOTE EXTRACTS MAY 11, 2011 BOARD OF DIRECTORS' MEETING

### I. APPROVAL OF MINUTES

<u>Voted</u> to approve the minutes of the Board of Directors' meeting of April 13, 2011, as presented and filed with the records of the meeting.

#### IV.A. Approvals

1. <u>Memorandum of Understanding and Financial Assistance Agreement</u> between MWRA and BWSC for Implementation of CSO Control Projects, Amendment 12 (ref. WW A.1)

<u>Voted</u> to authorize the Executive Director, on behalf of the Authority, to execute Amendment 12 to the *Memorandum of Understanding and Financial Assistance Agreement Between MWRA and BWSC for Implementation of CSO Control Projects*, increasing the financial award amount by \$784,598.00 from \$286,801,000.00 to \$287,585,598.00 and revising the language of the agreements in regard to the Total Award Amount and Interest.

2. <u>Extension of Employment Contract, Principal Civil Engineer, Deer Island</u> Treatment Plant (ref. P A.1)

<u>Voted</u> to approve the extension of the part-time employment contract for Mr. William A. Haynes, Principal Civil Engineer, Deer Island Treatment Plant, for a period of one year from June 1, 2011 to June 1, 2012 at the current hourly rate of \$46.65, for an annual compensation not to exceed \$54,581.00.

3. <u>Extension of Employment Contract, Administrative Assistant, Clinton</u> (ref. P A.2)

<u>Voted</u> to approve the extension of a part-time employment contract for Ms. Jane Densmore, Administrative Assistant, Operations Division, for a period of one year from July 1, 2011 to June 30, 2012 at the current hourly rate of \$21.00, for an annual compensation not to exceed \$21,840.00.

## IV.B. Contract Awards

1. <u>Grit and Screenings Hauling and Disposal: Charter Environmental, Inc., Contract OP-149</u> (ref. WW B.1)

<u>Voted</u> to approve the award of Contract OP-149, Grit and Screenings Hauling and Disposal, to the lowest eligible and responsible bidder, Charter Environmental, Inc., and to authorize the Executive Director, on behalf of the Authority, to execute and deliver said contract in the bid amount of \$1,567,994.66 for a term of 730 calendar days from the Notice to Proceed.
