NOTIFICATION OF PROPOSED GAS/OIL SEPARATOR INSTALLATION FORM

The Massachusetts Uniform State Plumbing Code, 248 CMR § 10.09 and Massachusetts Water Resources Authority (MWRA) Sewer Use Regulations, 360 CMR § 10.016, require that the Authority be notified of the installation of a new gas/oil separator in the MWRA Sewer District to ensure an inspection prior to backfilling. The gas/oil separator installation is subject to review and acceptance within the MWRA Toxic Reduction and Control Program.

Submit to MWRA this Notification Form and all supporting documents. Upon receipt, MWRA will review the submission, and contact you to schedule a field inspection. **Do not backfill until you receive clearance from the MWRA and approval from the local municipality.** All designs, constructions, and excavations conducted shall be in accordance with all federal, state, and municipal safety regulations. During the construction phase, you must assure and conduct all appropriate sheeting and shoring measures to protect the integrity of the gas/oil separator excavation site. The MWRA will meet with the competent person while on site for the inspection. For complete MWRA instruction guidelines and required documents for gas/oil separator(s), please visit MWRA's website.
