The Massachusetts Water Resources Authority (MWRA) is required by U.S. Environmental Protection Agency (EPA) regulations at 40 CFR 403.8(f)(2)(viii) to publish, at least once a year, a list of those Significant Industrial users (SIU) which, at any time during the previous twelve months, were in significant noncompliance (SNC) with applicable pretreatment requirements. This is a list of the SIUs in the MWRA sanitary sewer district that were in SNC during fiscal year 2023 (July 1, 2022 - June 30, 2023).

SNC is calculated throughout four overlapping six-month periods:

Q1: April 1, 2022 - September 30, 2022,

Q2: July 1, 2022 - December 31, 2022,

Q3: October 1, 2022 - March 31, 2023,

Q4: January 1, 2023 - June 30, 2023.

For each period, MWRA reviews the amounts of pollutants each industry discharged to the MWRA sewer system, the reports each industry filed with MWRA, and the actions each industry was required to take.

In fiscal year 2023, industries were in SNC for the following reasons:

D: Discharge of excessive amounts of pollutants.

R: Failure to timely file reports.

The list includes both the period during which the industry was in SNC and the reason(s) for SNC in each period.
