Dear Mr. Haas and Ms. Murphy:

I am pleased to submit five recently finalized interpretive synthesis reports providing results from MWRA's permit-required Ambient Monitoring program. Part I.7.c.iv of the permit requires:

"The results of all monitoring required by the ambient monitoring plan or the eutrophication model shall be reported to EPA, MADEP, OMSAP and NMFS, on a quarterly basis."

Two of the enclosed reports contain results of MWRA's water column monitoring in 2001. One contains results of a 2001 study targeting the algae which causes red tide. The final two reports contain 2001 results from MWRA's benthic nutrient flux and fish and shellfish studies, respectively.
