- Movement of hazardous materials by rail-The sale of Pan Am to CSX and the opportunity to increase safety measures to avoid a potential accident near the Wachusett Reservoir.
- Update on MWRA's progress toward reducing their carbon footprint. Possible joint meeting with WAC on proposed CHP project.
- The return of green certification for DCR watershed lands.

Lou Taverna concluded advisory board business and called for a vote to adjourn.
